Mr. Huschak:

On behalf of Interstate Power and Light Company (IPL), Alliant Energy has retained Sargent & Lundy L.L.C. (S&L) as the Engineer of Record to design the closure of certain coal combustion residuals (CCR) units in accordance with 40 CFR Part 257 Subpart D – Standards for the Disposal of Coal Combustion Residuals in Landfills and Surface Impoundments, as well as the Iowa Administrative Code (IAC), Chapters 567-100 through 567-103, and 567-108 at the M.L. Kapp Generating Station located at 2001 Beaver Channel Parkway Clinton, IA 52732. Construction began in April 2017 and closure of the inactive CCR surface impoundment is complete as of the date of this letter.

Based on S&L's field observations pursuant to our contract with Alliant Energy and the review of the Construction Documentation Report prepared by SCS Engineers, dated January 11, 2018, the inactive CCR surface impoundment has been closed in accordance with the applicable project specifications, design drawings, and the requirements of §257.102. Please note that a written Closure Plan (§257.102(b)) is not required for this facility as of the date of this letter. This notification is provided to meet the requirements of §257.102(f)(3).
