On behalf of Interstate Power and Light Company (IPL) – a wholly owned subsidiary of Alliant Energy – Alliant Energy has retained Sargent & Lundy L.L.C. (S&L) as the Engineer of Record to design the closure of the coal combustion residuals (CCR) surface impoundments and CCR landfills in accordance with 40 CFR Part 257 Subpart D – Standards for the Disposal of Coal Combustion Residuals in Landfills and Surface Impoundments, at the Prairie Creek Generating Station located at 3300 C St. SW, Cedar Rapids, IA 52404. Construction began in April 2018 and closure of the inactive CCR surface impoundment is complete as of the date of this letter.

Based on S&L's review of the Construction Documentation Report prepared by Foth Infrastructure & Environmental, LLC, dated December 18, 2018, the CCR surface impoundments have been closed in accordance with the applicable project specifications, design drawings, and the requirements of §257.102. This notification is provided to meet the requirements of §257.102(f)(3).
